## Important Information from the Joint bodies of the Executive Committee and the Board of Trustees:

As requested by the Election Committee, members of the Executive Committee and Board of Trustees met to discuss the criteria for "Good Standing" requirements. The following was decided as the basic criteria for the same.

***"An active member who has NOT done anything or performed any action against the goodness of TAGDV as an organization and anyone who has NOT committed any act which is against the general rules of law in a non-profit organization and who has NOT violated the bylaws."*** is said to be in Good Standing.

As action items from this joint meeting, the following were recorded.

- The members of the joint bodies of the EC and the Board will collaborate and consolidate a list of actions that will be defined as the probable actions of a member NOT in good standing status with TAGDV.
- The members of the joint bodies of the EC and Board will then finalize the list of actions by voting.
- The Election Committee will seek legal opinion within 7 days of receiving the list of actions to help decide if any listed action will legally determine a candidate as not in good standing status with TAGDV NPO.
- At this point, if any of the newly elected members are found NOT in "Good Standing" by a joint session of Board and EC, after applying the legal opinion, they will be required to quit from their positions.
- Until all these legal processes and follow-up steps are implemented and completed, the current Election Committee will be in effect for as long as it takes, even if it goes into 2024.
