Statement from the Election Committee

The following message from the Election Committee is being shared directly with the General Body.

The voting has ended! Thanks to everyone for a very successful transparent on-line voting event.

On November 1st the Election Committee communicated to the General Body about the Candidate Eligibility status, and we declared that "Election Committee has determined that all candidates are allowed to proceed further". We also stated that "Since the Election Committee received a detailed complaint from the President of the organization, it is imperative that the Board takes appropriate action including seeking legal opinions".

Since then, we have received a flurry of additional emails with several accusations. We have reviewed the accusations closely and do not find anything to change our original determination of Eligibility to contest. The Board has also respected our directive and has sought legal opinion and has received the legal view to withhold the election results. It would be proper for the Board to initiate a DUE PROCESS (hearing from all named individuals) as defined by the TAGDV bylaws. Needless to say, the decision must be binding for all named parties.

The Election Committee takes its responsibility very

seriously. We have provided first time on-line presentation of candidates, on-line voting, corrected an erroneous electoral process followed during last three election cycles and reintroduced position specific voting. We have also enhanced our database. For the first time, we have many spouses with their own email addresses in the membership database. It is encouraging to note that a large percentage of General Body had exercised their vote.

The voice of the General Body rules. Election Committee is duty bound to respect the voice of the General Body. However, it might be prudent to hold announcing the Board election results untill the accusation issue is resolved by the Current Board /EC within two weeks. The election results for the Board will be announced and validated if we do not hear from the Current Board/EC by then. However, Executive Committee results will be released as planned, by 5 PM today.

The results will be opened by the Secretary in my presence and that of the two Senior leaders of TAGDV, Dr. Ramachandran Sivakumar and Prof. Raj Mutharasan. Election Committee reports only to General Body. Any appeal to override the above guideline should be approved by the General Body. It has been an honor to serve in the Election Committee and all three of us thank TAGDV for this great opportunity.

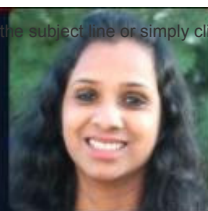
