## Bylaw amendment update

Per the update provided at the Nov 4th, 2023 general body meeting, TAGDV's Bicameral bodies will be proceeding with implementing the amended Bylaws. The amended bylaws will be deemed effective from **April 29th, 2023**.

The Bicameral bodies respect the dedication and decision of TAGDV members who voted on bylaws during the April 29<sup>th</sup>, 2023 event, overwhelmingly approving amendments to the bylaws. The bicameral bodies called for three general body meetings in the last 12 months to discuss, review, get feedback and update the bylaws, and the final content was drawn out by bipartisanship and consensus from the meeting on April 25th, 2023. We would like to thank the General Body who kindly cooperated with us and traveled with us for more than a year, since the start of the bylaw updates process in May 2022, providing feedback through emails and general body meetings. Thank you!

As next steps, the new Bylaws will be updated on our website and a copy of the amended bylaws shall be sent to the IRS. A precedent remains from the prior major amendment of bylaws in 2011 with a limited

number of approval votes, the version of Bylaws that our Association has been following diligently for the past twelve years. We thank you all for your kind cooperation in this regard.

## **Board Candidate complaints and “good standing” determination**

TAGDV Board would like to update the General Body on complaints received against candidates running in the election for the Board and the due process of handling them.

Per Election Committee's directive, the Board has initiated a legal consultation with an Attorney and instituted a due process to validate and determine facts around the complaints. The due process will be independently conducted by a committee of five pioneering and experienced past Presidents of TAGDV as a fact-finding mission, where candidates alleged with complaints will be given an opportunity to answer/explain/defend themselves with evidence. Based on the Fact-finding committee's report after applying legal opinion, a joint Board-EC session (as per our Bylaws) will decide to qualify/disqualify candidates on grounds of being in 'Good standing or Not' and recommend the same to the Election Committee. The Election Committee will then proceed with the next steps. Thank you for your understanding and kind cooperation.
