**Sharing the following message from Election Committee 2023.****Board of Trustees transition status:**

The Election Committee is responsible for transitions for all positions for which we hold elections. The bylaw change was passed on Saturday November 4<sup>th</sup> before the General election concluded. The subsequent referendum on the candidate's good standing status was held well after that.

On December 9<sup>th</sup>, we asked the outgoing Executive Committee to hand over all the documents and records received from the prior Executive Committee (2020-2021) to the newly elected Executive Committee. Reviewing the replies from the Treasurer and specifics of the missing data provided by the President, the Election Committee must place a hold on the transition of the Board until there is additional clarity due to recent lawsuit filings against the three (S. Paramasivam, V. Selvaraj and B. Chinnusamy). We are requesting the current Board to continue until the hold is removed. Since there is a fifth position and there are no accusations against

Mr. Siva Prasath, is requested to join the Board effective January 1<sup>st</sup>.

Any power is useless unless it serves the needs of the community. The Election Committee is saddened to see all the email accusations that have emerged over the last six weeks or so, which may cause long-term damages to the Association. Thus, the Election Committee is directing the Board to set up a 'Peace Committee' with the goal of finding common grounds to close the differences. As the Fact Finding Committee is already aware of the background, we are asking them as well as other respected senior leaders of TAGDV to be part of this 'Peace Committee'.

The open issues noted above resulted from the transition of the earlier Executive Committee to the current outgoing Executive Committee. Because the newly elected Board members are representatives of the earlier Executive Committee, all alleged open transition issues (documents, email, details of expenditure, etc.) **must be closed by the two respective Executive Committees to a satisfactory level for the Election Committee to remove the hold.** We are giving a time deadline of one month from today for this process to be completed.

This is our Tamil Association. We need to make sure that we protect the original intent of the Association. If these open issues are not fixed now, it will continue to divide our Association, causing further damages. It is requested in the interest of TAGDV that all individuals concerned cooperate and collaborate in resolving the conflict and bringing about peace. As leaders of the group, we must lead the way to resolve our differences and work together for the sake of the children. They are watching us closely.
